CONTINUE TO BE AWARE OF SCAMMERS

The following information was received from the Diocese. Please always double check when asked for donations of ANY kind online!

Online "phishing" scams continue to target churches and clergy, and they require everyone's awareness and vigilance.

Scammers' tactics vary, but a common one is to send e-mails or text messages that appear to be from a known organization or church leader (such as a bishop or rector). They typically ask for urgent help or a favor, and request that the recipient buy and electronically send gift cards, make donations via money transfer or provide personal information.

Church leaders should inform their congregations about these scams and reinforce the message that bishops, clergy and church leaders will never ask for help or donations in this way. Recipients should be skeptical of unexpected e-mail or text message requests to send or spend money or provide urgent assistance. Check the sender's e-mail address for legitimacy before responding or opening any links or attachments. E-mail from the bishops and diocesan staff, for example, will come from the designated e-mail domain @diomass.org, not from gmail.com or other e-mail providers. If a request seems to be authentic, confirm with the requester using known contact information.

Please keep the Bourne and Wareham Substance Free coalitions in your prayers. We have not been meeting due to the Corona Virus precautions. The next meeting of our group will be in limbo until we get an all clear from the diocese. Please hold all those who suffer from addiction and in recovery in your prayers.

Did you know, that according to a recent Cape Cod Times article, "The Bourne Fire Department reports that Opioid deaths and emergencies have increased significantly during the first three quarters of 2020" The struggle for many continue and with increased unemployment and loss of benefits many are resorting to street narcotics for pain relief.

A large part of the recovery process is supported by the traditional 12-Step Group meetings These groups have been unable to meet during the crisis and it must be difficult for them at this time.

AA meetings can now be available by phone 4 times a day, seven days a week, 7:00AM, 12NOON, 2:00PM and 5:00PM by calling 425-436-6360 Access #n422932. If you have loved ones or friends who are dealing with substance abuse issues, please try to have an open ear and an open heart to be there for them.

If you are concerned for a friend, family member or yourself, you can call the Massachusetts Substance Abuse Information and education Helpline at 1-800-327-5050. As we give thanks for the blessings of our lives please keep those suffering from addiction in your prayers.
